### MEETING MINUTES - VILLAGE BOARD (Regular)

Date/Time: Tuesday November 18th 2025 (6:00 P.M.)

Location: Hobart Village Office (2990 South Pine Tree Road)

#### **ROUTINE ITEMS TO BE ACTED UPON:**

- 1. Call to order/Roll Call. The meeting was called to order by Rich Heidel at 6:01 pm. Dave Dillenburg, Vanya Koepke, Melissa Tanke, Tammy Zittlow, and Rich Heidel were present.
- 2. Certification of the open meeting law agenda requirements and approval of the agenda ACTION: To certify the open meeting law agenda requirements and approve the agenda. Note on 7.A. the amount is not \$4,784,76 but \$4,784.76. MOTION: Koepke SECOND: Zittlow. VOICE VOTE: 5-0.

#### 4. PUBLIC HEARINGS

#### A. PUBLIC HEARING - To consider the FY2026 General Fund, Capital Projects and Debt Service Funds

The proposed budget calls for a tax levy of \$3,813,462.58 (an increase of 5.5 percent over the 2025 levy), resulting in a \$0.15 increase in the mill rate (3.9 percent).

President Heidel opened the Public Hearing 6:03 PM.

This resolution will set the general property tax levy in the amount of \$3,813,462.58 for Village operations, and an overall levy of \$5,392,459.14 including tax increment districts. The resolution also establishes the Refuse and Recycling fee of \$216.00 (\$18.00 per month) for a 96-gallon refuse bin and \$195.00 (\$16.25 per month) for a 65-gallon refuse bin per residential unit, as well as the 2026 Storm Water Management Utility Special Charges - \$77.00/Equivalent Residential Unit ("ERU").

## B. DISCUSSION AND ACTION - ORDINANCE 2025-12 (AN ORDINANCE TO AMEND SECTION 4 (PUBLIC NUISANCES AFFECTING PEACE AND SAFETY) OF CHAPTER 207 (NUISANCES) OF THE MUNICIPAL CODE OF THE VILLAGE OF HOBART, BROWN COUNTY, WISCONSIN)

The purpose of this Ordinance is to add language to the Nuisance section of the Municipal Code that prohibits projecting or reflecting objectionable light onto a public roadway or walkway or any neighboring use or property and would prohibit directional lighting from being directly aimed at neighboring properties.
