11. NEW BUSINESS

A. DISCUSSION AND ACTION - Proposed FY2026 General Fund, Debt Service and Capital Projects Budgets

The proposed budget calls for a tax levy of \$3,813,462.58 (an increase of 5.5 percent over the 2025 levy), resulting in a \$0.15 increase in the mill rate (3.9 percent). The increase in the mill rate will result in the owner of a \$300,000 home paying \$45 more in Village property taxes: Virtually the entire levy increase is due to the full impact of the 2023 Fire Station bond on the Debt Service Fund. This was predicted in the initial funding presentation done in February 2023. The budget includes a proposal to add one (1) part-time position (Administrative Assistant) to the staff. A Public Hearing will be held at the November 18th Board meeting.

Administrator Kramer reviewed the proposed FY2026 General Fund, Debt Service and Capital Projects Budgets.
